



SUMMARY ANNUAL REPORT FOR NXP USA, INC. EMPLOYEE HEALTH BENEFIT PLAN

This is a summary of the annual report of the NXP USA, Inc. Employee Health Benefit Plan (Employer Identification Number 20-0443182, Plan Number 501) for the plan year 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

NXP USA, Inc. has committed itself to pay certain dental, severance and employee assistance program claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Vision Service Plan, Metropolitan Life Insurance Company, Kaiser Foundation Health Plan Inc., MetLife Legal Plans, Aetna International, Aetna Life Insurance Company and Life Insurance Company of North America to pay certain life, accidental death and dismemberment, medical, vision, dental, temporary disability, long-term disability, legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$10,177,914.
