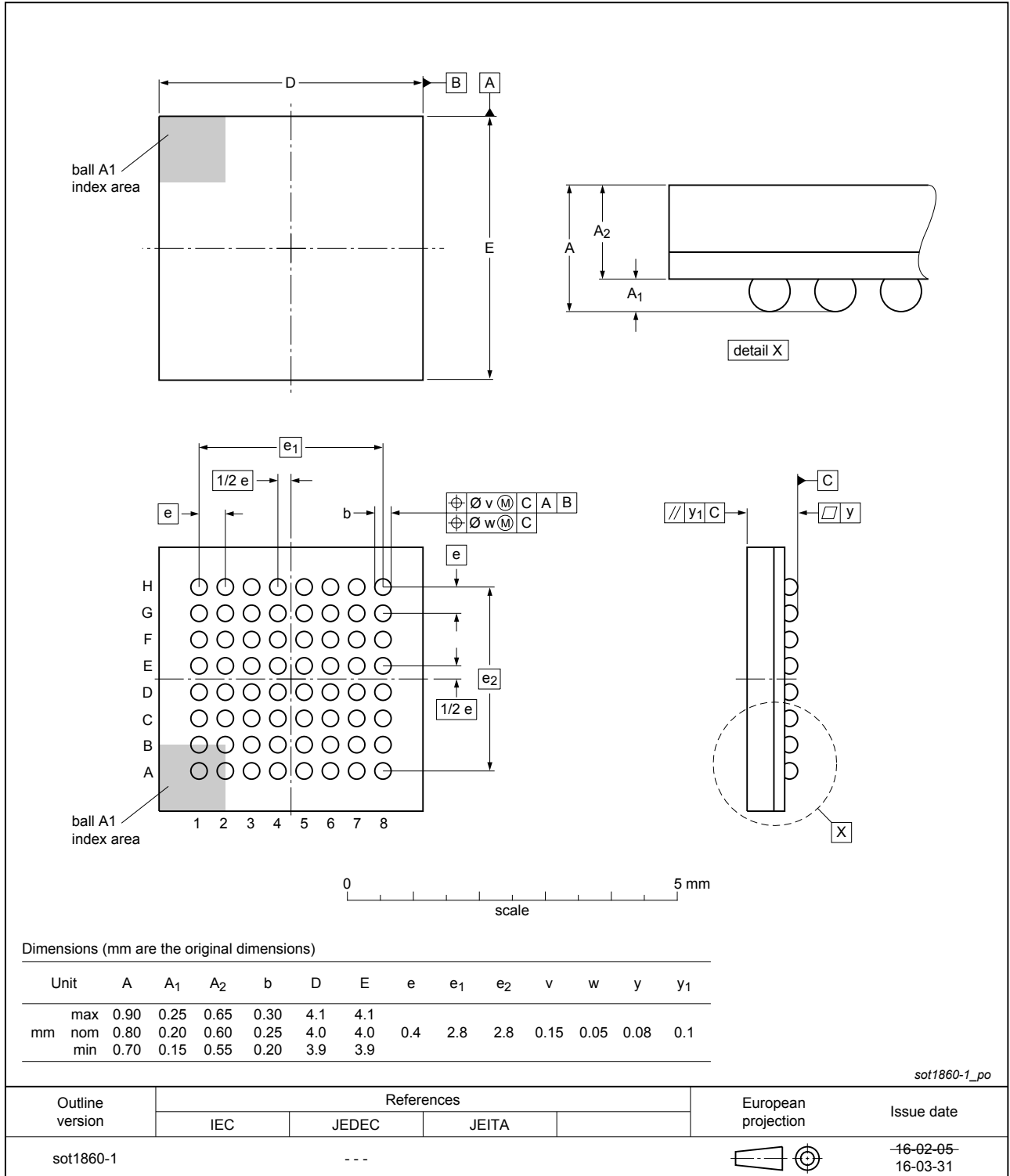


Fig. 1. Package outline VFBGA (SOT1860-1)

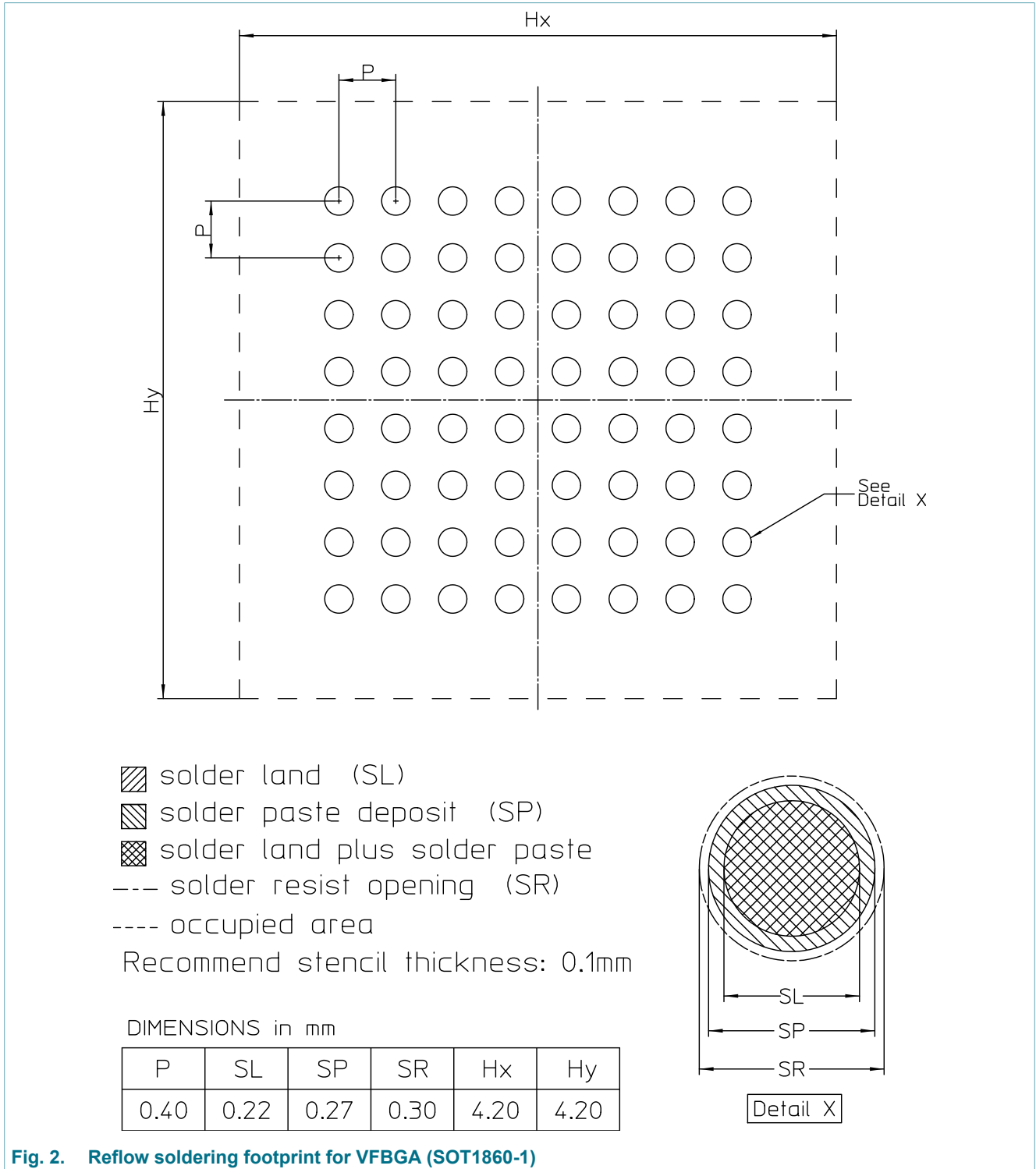


Fig. 2. Reflow soldering footprint for VFBGA (SOT1860-1)
