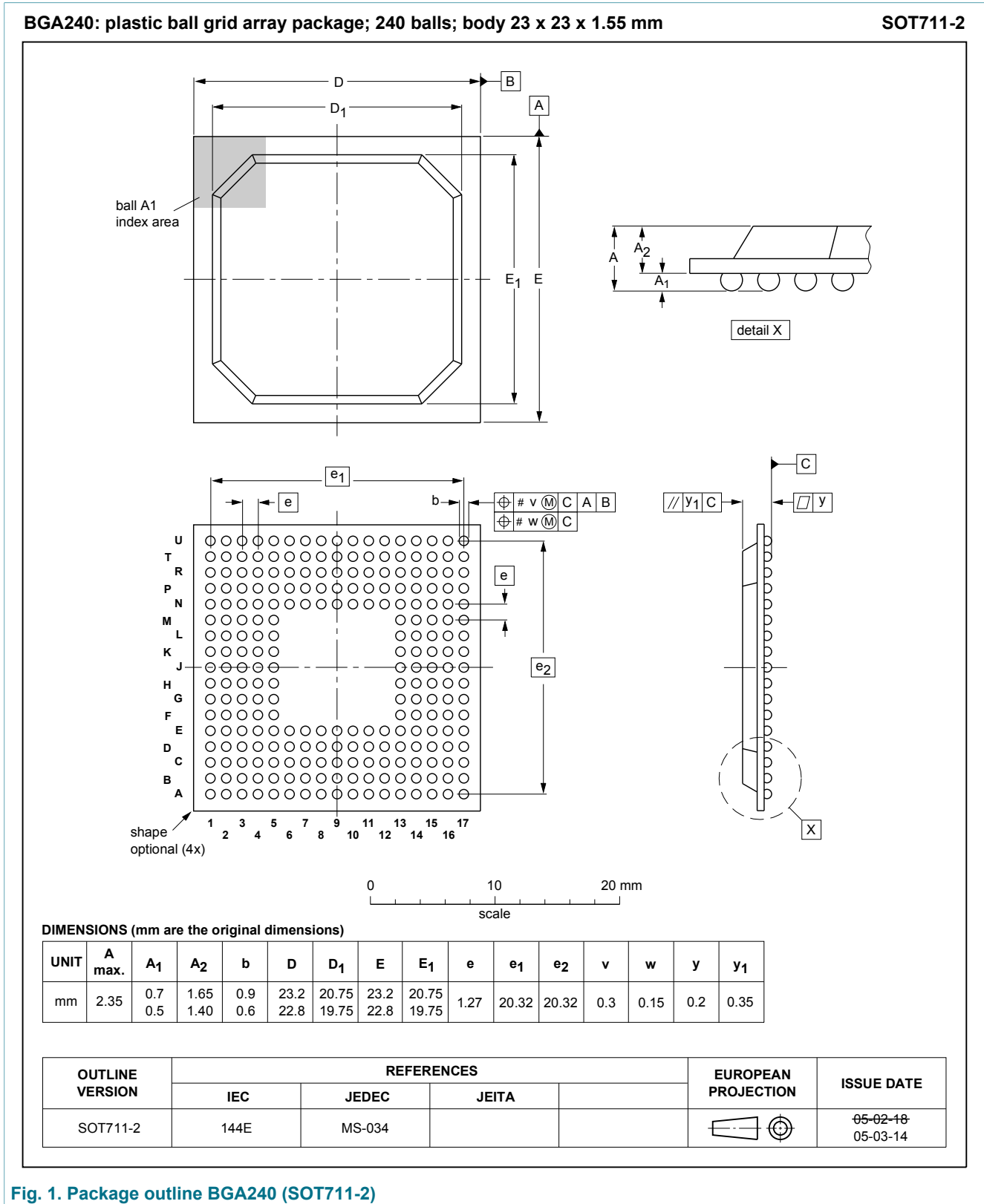


Fig. 1. Package outline BGA240 (SOT711-2)

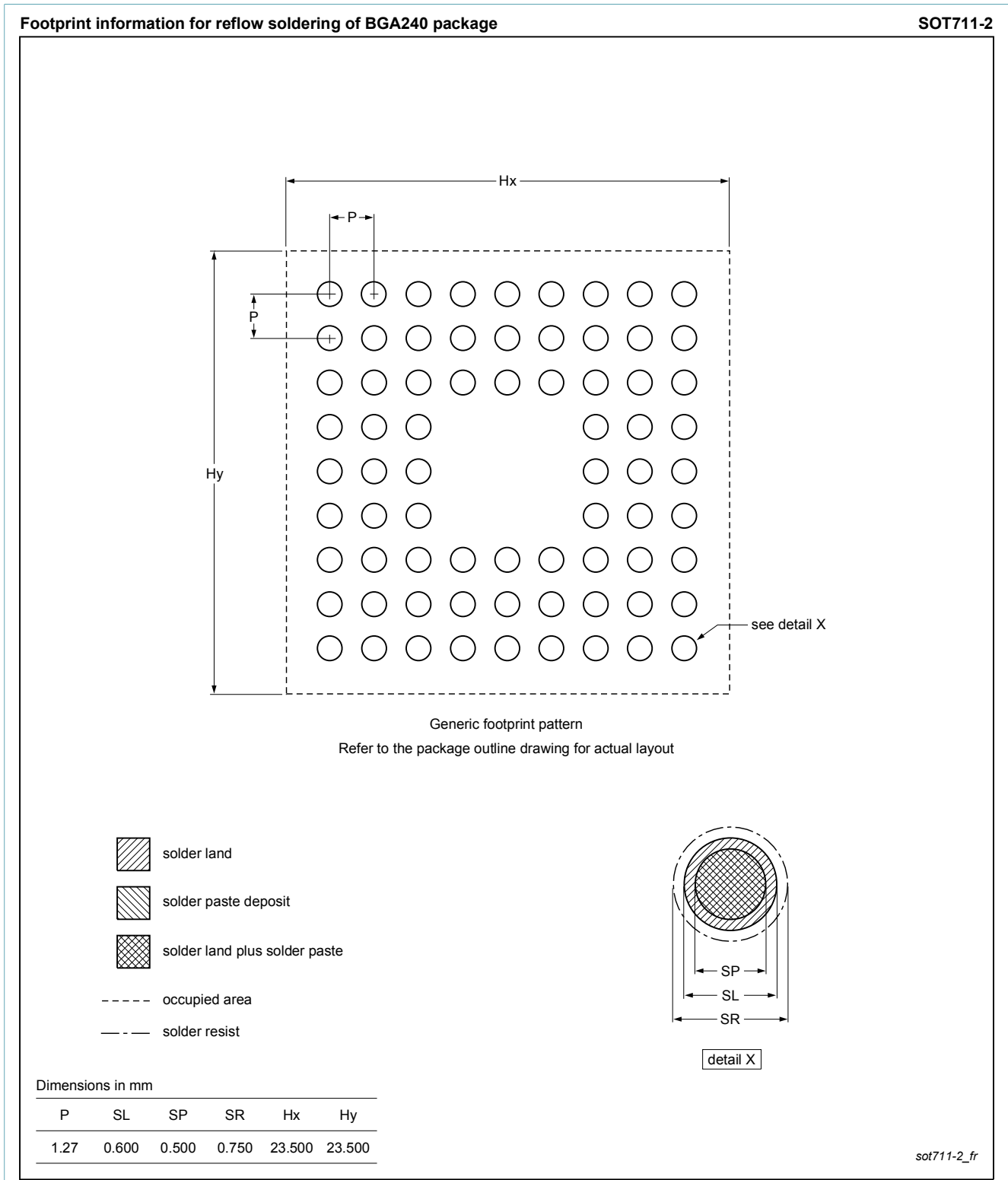


Fig. 2. Reflow soldering footprint for BGA240 (SOT711-2)
