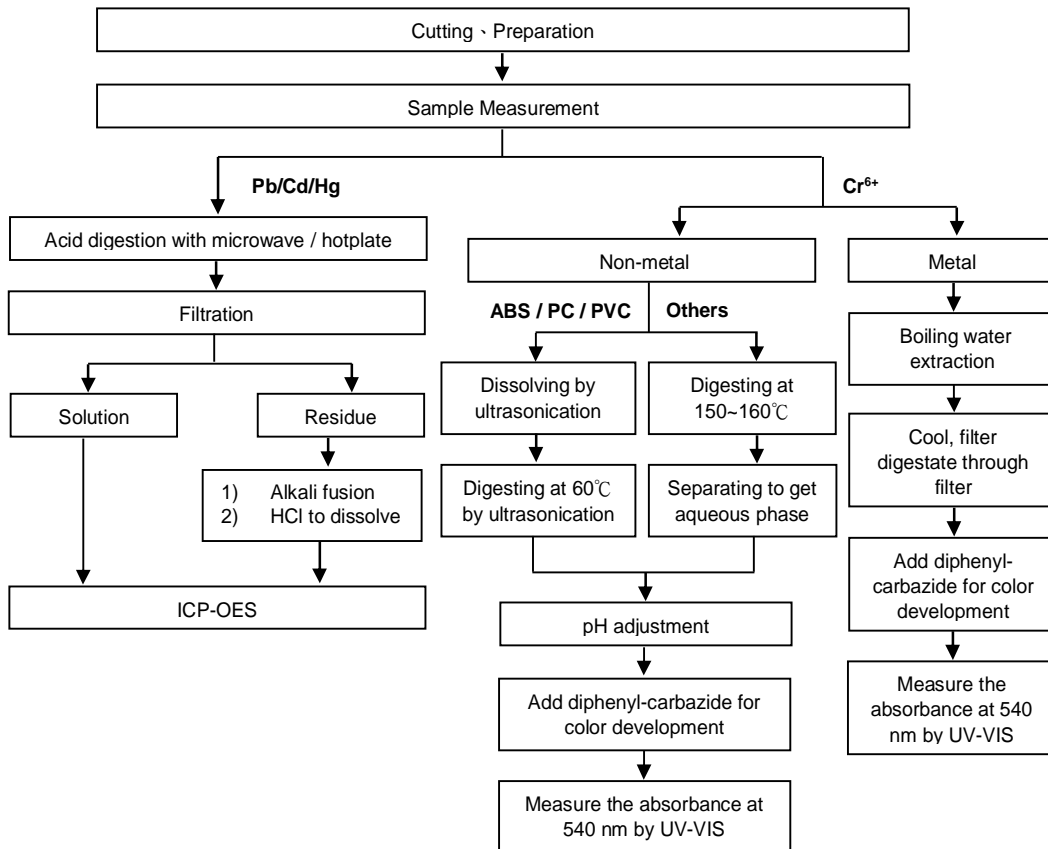

Analytical flow chart of Heavy Metal

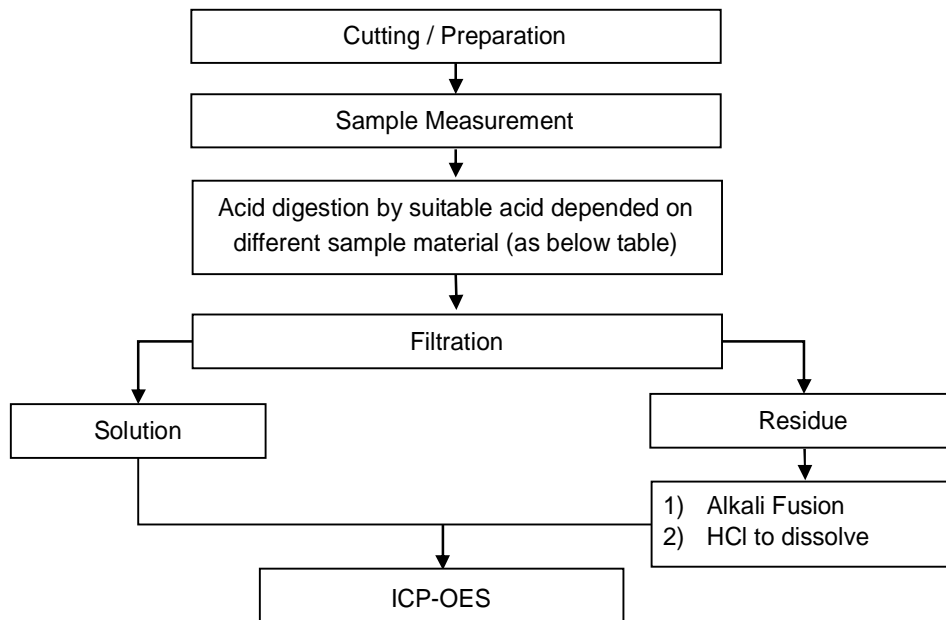

Flow Chart of digestion for the elements analysis performed by ICP-OES

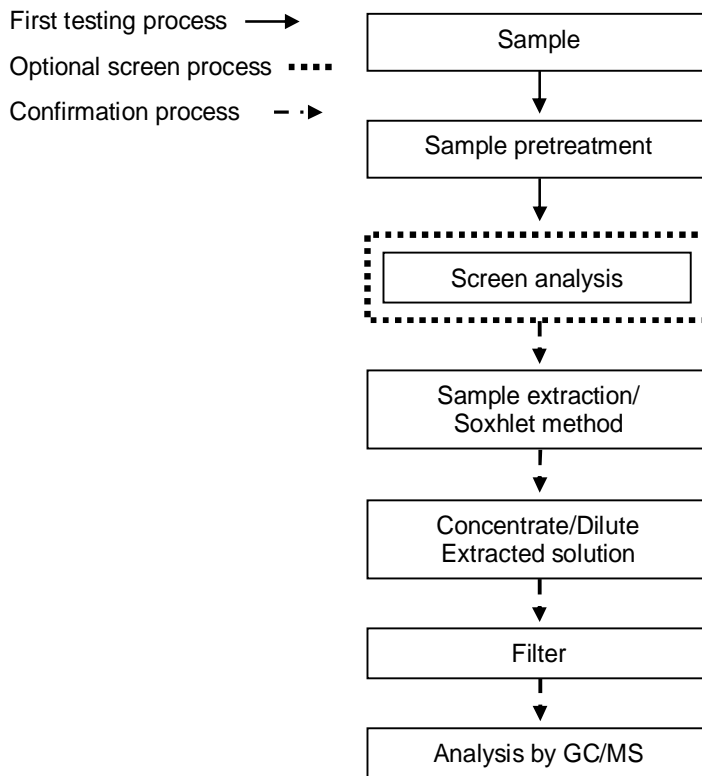

Analytical flow chart - PBB/PBDE

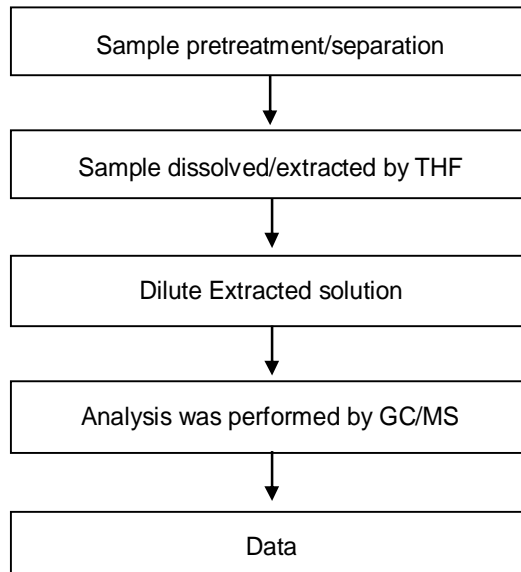

Analytical flow chart - Phthalate

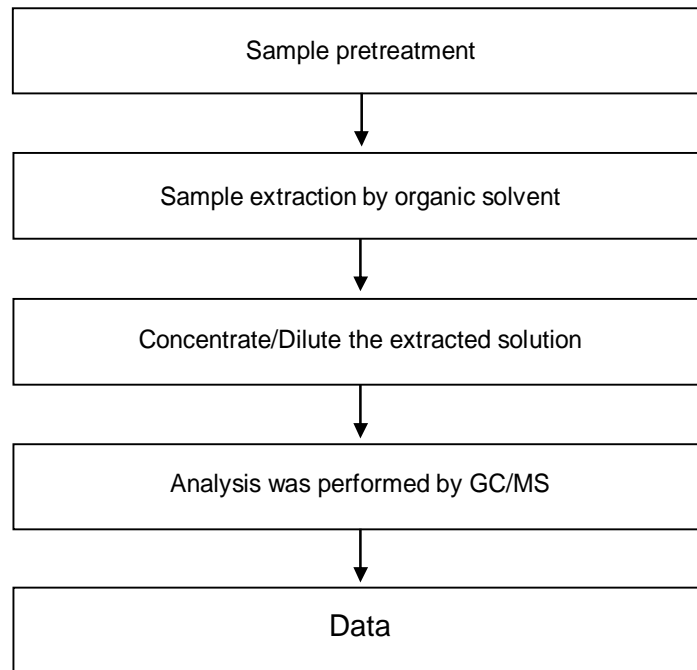

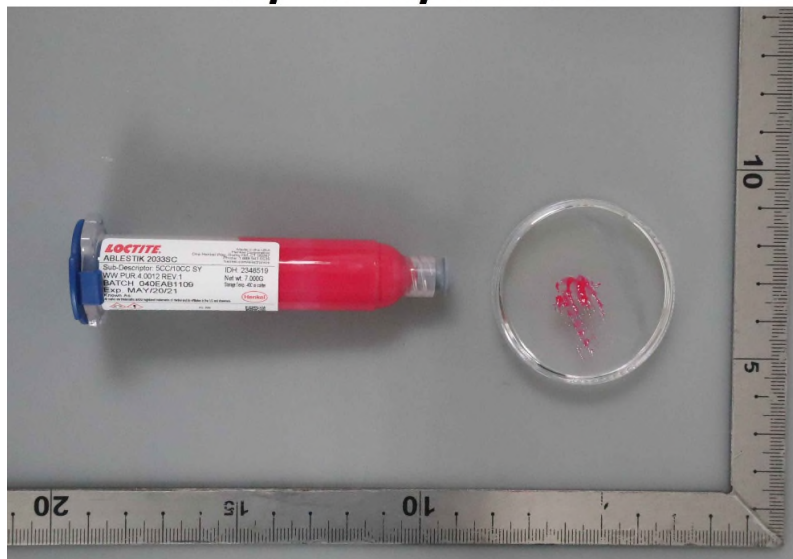
