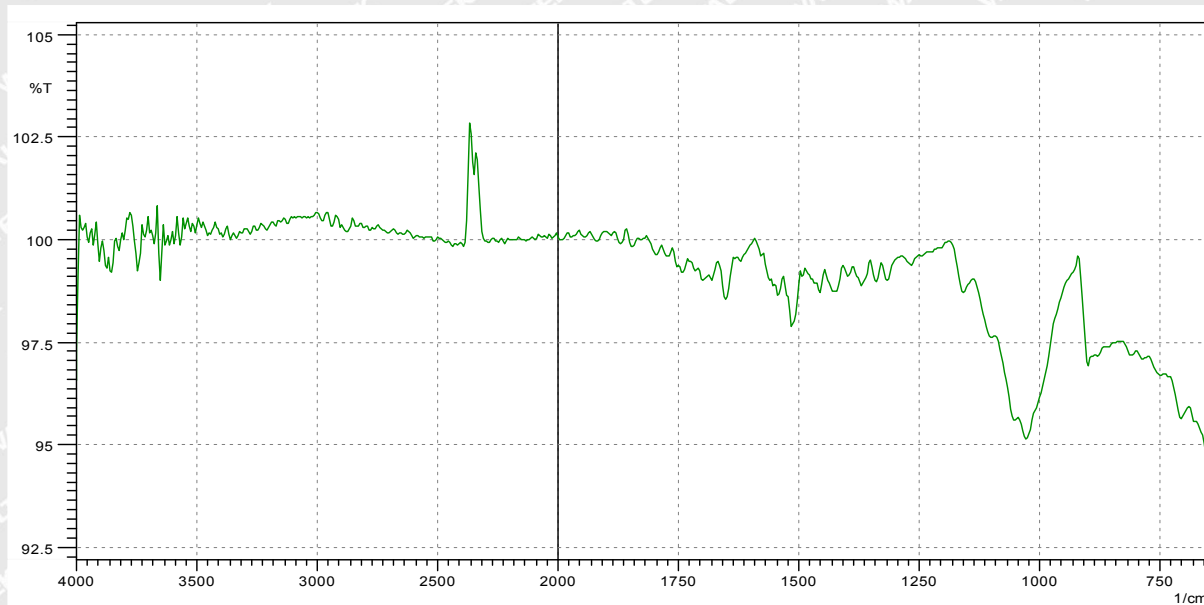

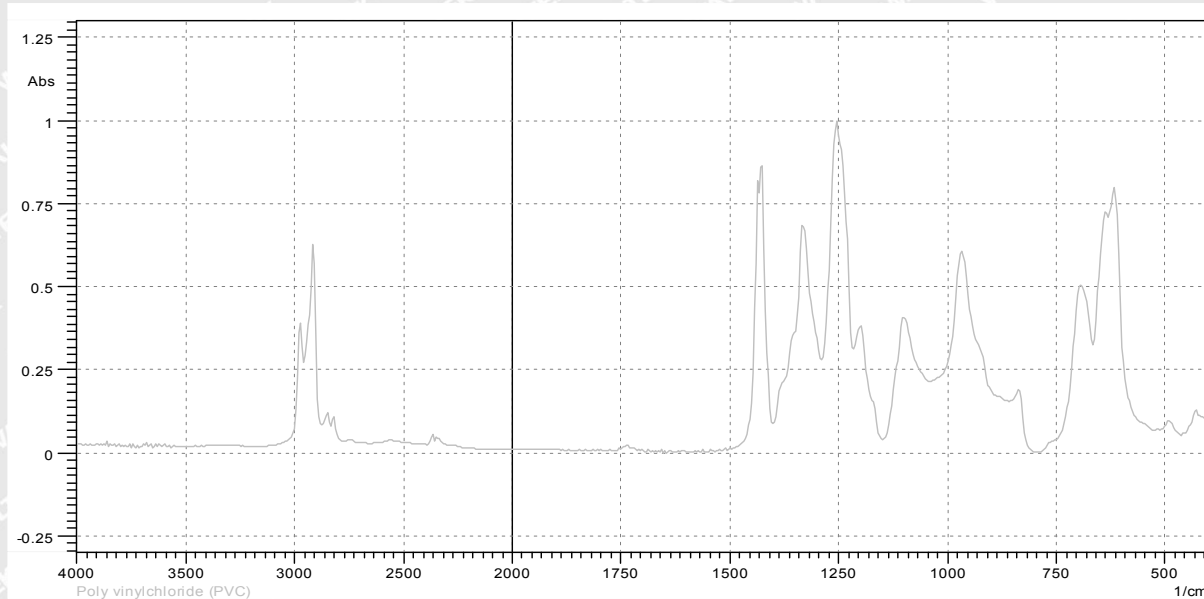

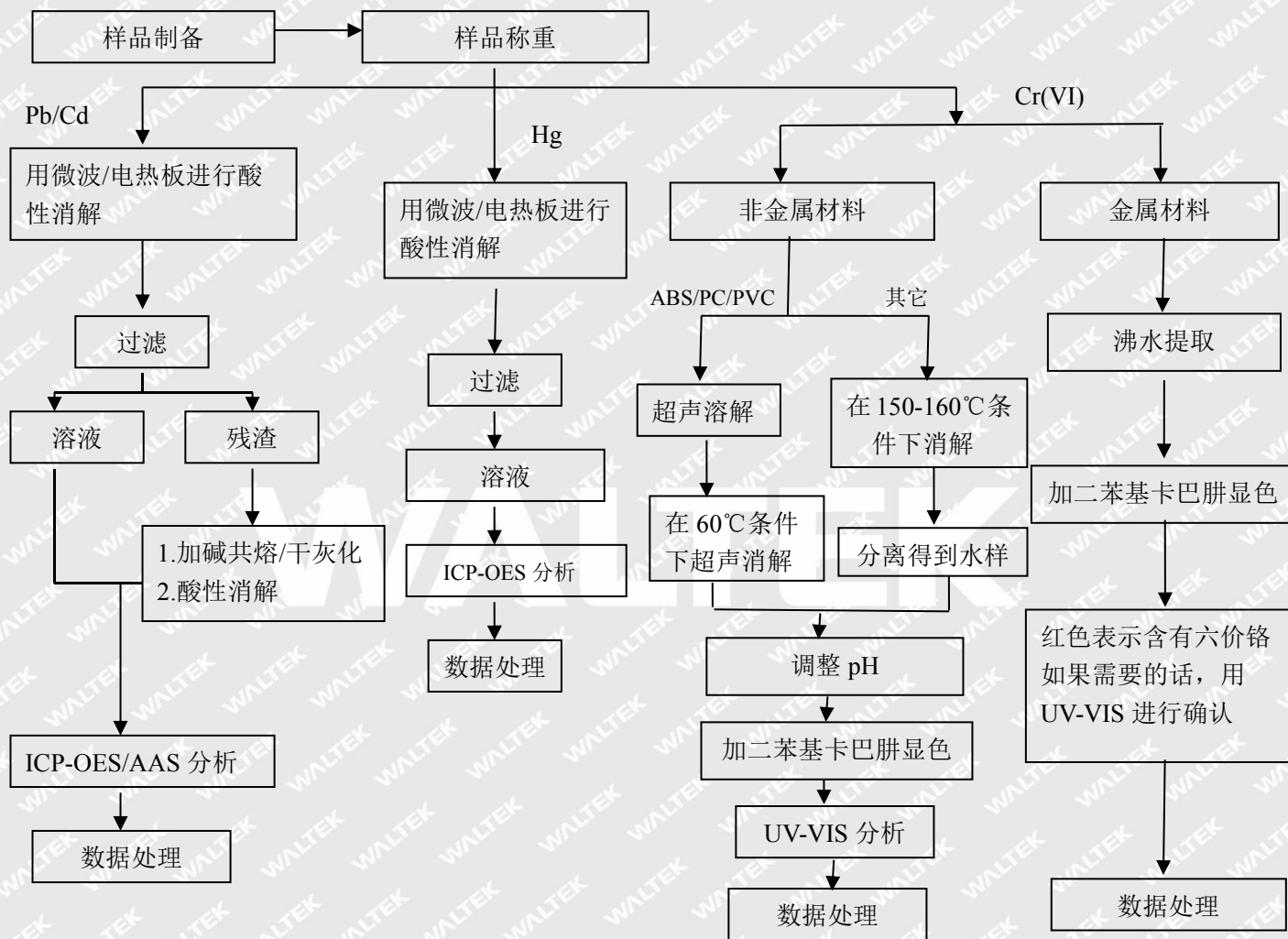

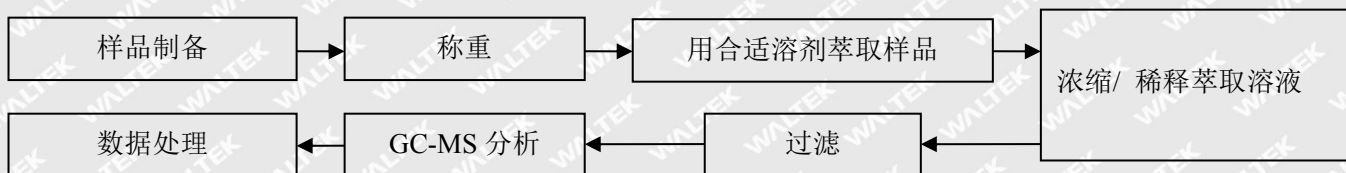

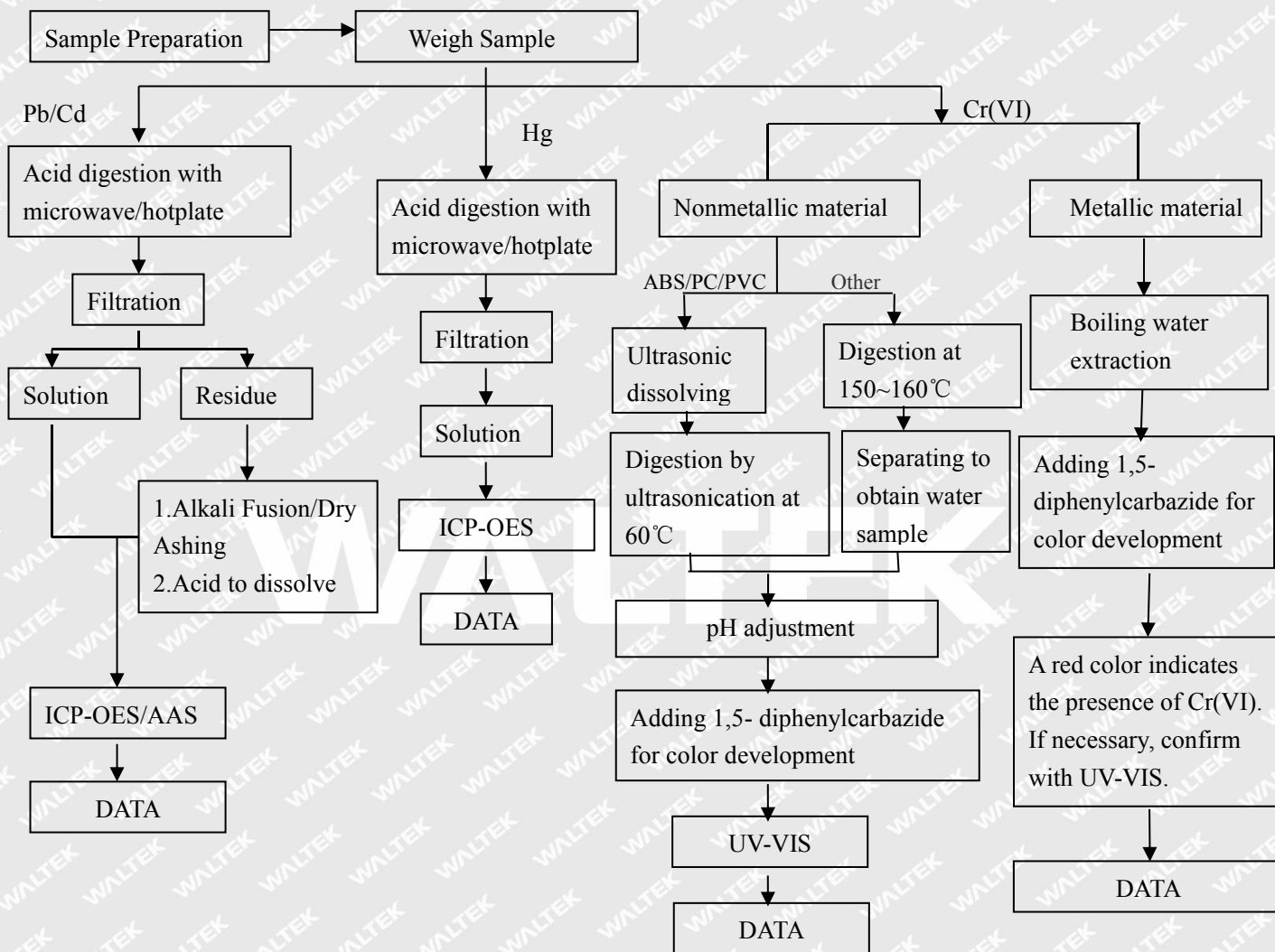

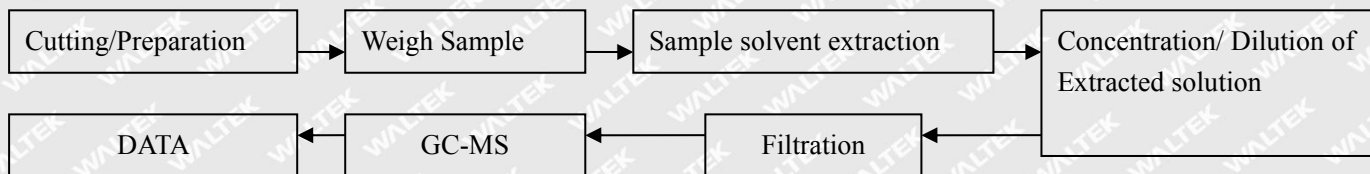

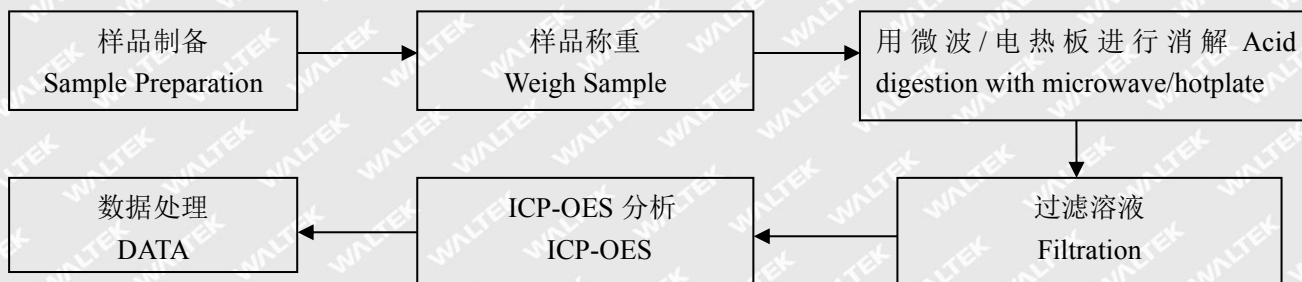




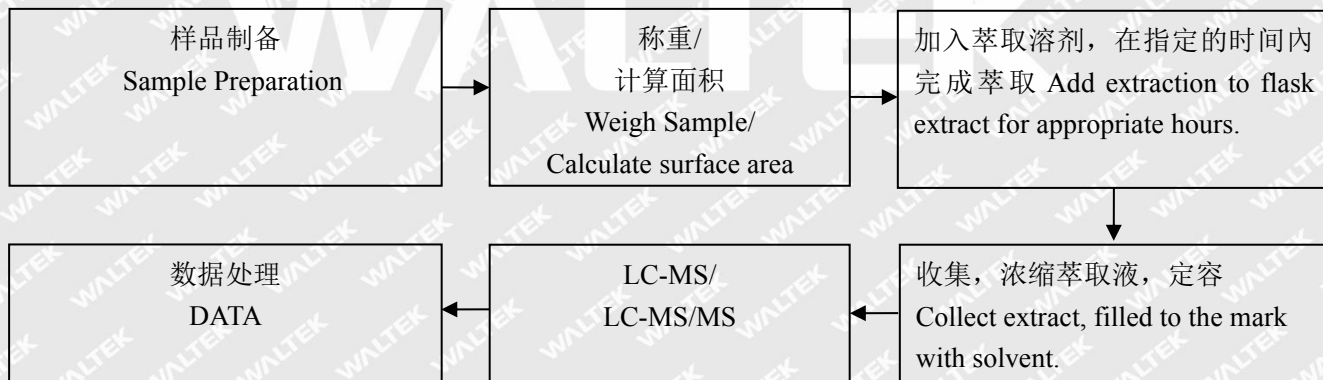

## 全氟辛酸磺酸、全氟辛酸的检测流程图 (Test Flow Chart for PFOS, PFOA)

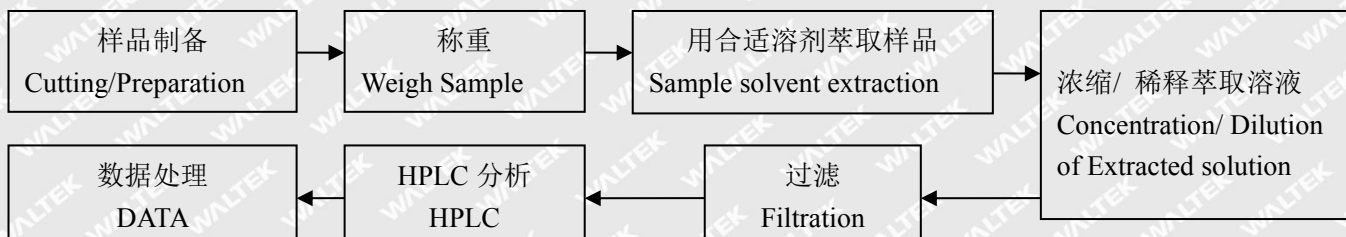
